#### WHAT TO KNOW FOR 2024

**Eligibility**- Eligible persons must be Lebanon County Residents & must be 60 years of age or older during 2024. Annual Household Income guidelines are:

1 Person- \$27,861 5 people- \$67,673

2 People- \$37,814 6 People- \$77,626

3 people- \$47,767 7 People- \$87,579

4 people- \$57,720 8 People- \$97,532

**Benefits**- Eligible persons receive five-\$10 checks for **a total benefit of \$50.00 one time** during the program year.

**Time Frames**- Check distribution between June 1 and Sept. 30, or until all gone. Checks expire on Nov 30.

**Eligible Food**— Senior FMNP checks may only be used to purchase produce grown in Pennsylvania.

The purpose of the Senior FMNP, administered by the Pennsylvania Department of Agriculture is (a) to provide seniors resources in the form

of fresh, nutritious, unprepared fruits & vegetables from farmers' markets and (b) to expand the awareness and use of farmers' markets.
