Position Available for Appointment: West Lebanon Township Commissioner

The Court of Common Pleas of Lebanon County is now accepting applications from interested persons for the position of West Lebanon Township Commissioner. The position is open due to the vacancy caused by the resignation of Tina M. Houser. The position will be filled by appointment pursuant to Section 530 of the First Class Township Code (53 P.S. §55530). The appointed candidate's term will terminate as of January 2, 2023.

Interested applicants must be registered electors of West Lebanon Township and have resided within the Township for at least one (1) year. Interested applicants must submit an application and a resume of their full educational background and work experience, a statement of their goals and objectives as Township Commissioner if selected for appointment, and a criminal background investigation waiver. Applicants must submit one original and five (5) copies of the applications, resumes, statements, and waiver forms. Applications will not be accepted after 3:00 p.m. on Wednesday, May 4, 2022. No telephone calls or e-mails will be accepted. Please note that all applicants shall be subject to and by submitting an application agree to undergo a complete personal and criminal background investigation. After the deadline for filing has expired, all paperwork submitted, except the waiver*, will be available for public inspection. Prior to the deadline only the identity of the applicants will be subject to public disclosure.

The Board of Judges will review the applications submitted and determine which candidates will be interviewed. Interviews will be scheduled accordingly. Thereafter, the Board of Judges will meet and will determine the successful candidate by vote.

* The criminal background investigation waiver form will not be released since it contains sensitive personal identifying numbers that could facilitate identity theft.
