## BRIEF DESCRIPTION OF DUTIES AND QUALIFICATIONS:

The Director of Security is in charge of all uniformed Correctional Staff, as well as all security and investigative operations within the Correctional Facility related to inmates and staff. This position requires a highly skilled individual possessing comprehensive knowledge in areas such as correctional security, safety, first aid and CPR, firearms, prisoner's rights, use-of-force, self-defense, report writing, and other aspects related to corrections and law enforcement in general. This position requires scheduled meetings with Security Supervisors and correctional staff, as well as conducting frequent tours of inmate housing areas and staff control areas as required according to the facility's accredited Training Academy and audits by the PA Dept. of Corrections. This is a management position, which requires the ability to effectively communicate verbally and in writing while directing correctional staff. Attention to detail is an essential attribute possessed by the qualified applicant regarding all facets of this position. Maintaining updated training certifications is required of this position. The Director of Security, Captain, reports directly to the Deputy Warden of Operations concerning all matters related to security operations, staff/inmate investigations and personnel matters. This position requires a thorough understanding of legislated correctional law, particularly Title 37 Section 95 of PA Code.

## MINIMUM EXPERIENCE AND TRAINING REQUIREMENTS:

Applicant must be a high school graduate, as well as a graduate of the PA Department of Corrections Basic Training Academy or equivalent working experience in the field of corrections. The candidate must have prior supervisory training or experience in a law enforcement capacity and a minimum of five (5) years of working experience in corrections. Certifications related to the field of corrections are a plus but not a requirement. Applicant must have a flexible schedule and the ability to accommodate all security shifts and support staff within a 24-7 operation.
