MONUMENT PARK - RULES and REGULATIONS

- (1) No pets permitted in Park.
- (2) Boisterous, immoral or indecent conduct is prohibited.
- (3) Alcoholic beverages are prohibited.
- (4) Children under eight (8) years of age must be adult supervised at all times.
- (5) Trash, garbage and all other litter shall be placed in containers provided, no home garbage permitted.
- (6) Removal, defacing or damaging of public property is prohibited.
- (7) No roller skating or skate boarding permitted.

REQUIREMENT: CERTIFICATE OF COVERAGE – \$1,000,000.00 MINIMUM PROOF OF LIABILITY INSURANCE <u>must</u> be provided to the County Commissioners Office before the date of your event.

AMPLIFIED SOUND SYSTEM IS NOT ALLOWED INSIDE MONUMENT PARK.

Sound equipment, *not electrically* enhanced or modified, will be permitted inside the park to communicate with the individuals in the immediate area. Sound heard outside the perimeters of Monument Park violates the City of Lebanon's Ordinance of Disturbing the Peace. Enforcement of the Ordinance is at the discretion of the City Police.

PENALTY

Violators of this Ordinance Number 20 shall be fined not less than fifty dollars (\$50.00) nor more than three hundred dollars (\$300.00) and/or shall be imprisoned not more than ninety (90) days.
