The Board of Commissioners held a workshop session meeting. All members present.

At 1:30 p.m., the Board of Commissioners met with Elections Director Sean Drasher and Deputy Director Suzanne Houser to review an Amicus Brief submitted by the County Commissioners Association of PA (CCAP) to the State Supreme Court on Monday.

At 1:40 p.m., Community Health Council's Nikki Gray and Lebanon Christian Ministries, Bryan Smith requested ARPA funding for a housing study that will cost between \$35-\$50,000. The City has pledged funding, but an amount was not specified. Once funding is secured, a Request for Proposal will go out to use new census data to determine the number of current rentals compared to demand for rentals (needs analysis) verses home ownership. The Market Analysis will take 6-10 months to complete. Nikki stated the Analysis is needed to facilitate the writing of grants. At 2:10 p.m., Bob Arnold, Randall Leisure and Craig Zemitis of the Conservation District as well as Courtney Ryman from the Conservancy, presented a request for a transfer tax for farmland preservation. There are 30 farms on the waiting list representing 2900 acres at a cost of \$2500/acre, it would take \$7.5 million to preserve all of these farms. Further, Arnold believes we are losing 1,000 acres of farmland to development each year.

At 2:40 p.m., Tom Kotay, John Wengert, Todd Dissinger, Jon Fitzkee, and Song Kim of the Lebanon Valley Rail Trail (LVRT) discussed a request for ARPA funds to complete .6 miles of trail on Phase 10A from Huckleberry Lane to just south of Jonestown Bible Church, and north of Route 22. An allocation of \$400,000 toward the grant request would provide a needed match to qualify for the grant and demonstrate a local commitment to the project.
