NOTE: You qualify for a resident fishing license if you are a bona fide resident of Pennsylvania. You must show positive proof of permanent residency. Senior Resident and Lifetime licenses are available to those persons at any time during the year in which they will become age 65.

National Guard & Armed Forces Reserve Licenses are available to those persons who provide documentation that within the previous 24 months, the person was deployed overseas as a member of the armed forces for a period of 60 consecutive days or more or was released early from the service describe above because of injury or disease incurred in the line of duty.

Service members limited to one license for each qualifying deployment.

Federal Travel Vouchers or Discharge papers may be used to verify service status.

The cost of the National Guard license is \$1.90, plus the \$1.00 issuing agent fee and requires the purchase of appropriate stamps and/or permits.

***The angler must be a bona fide Pennsylvania resident, be on active duty, be stationed outside Pennsylvania and be here on authorized leave. While in the act of fishing, the military personnel must carry proof of each of these requirements, such as a Pennsylvania drivers license or their military ID, and valid military orders showing their place of assignment and leave status.

NOTE: You qualify for a resident fishing license if you are a bona fide resident of Pennsylvania. You must show positive proof of permanent residency. Senior Resident and Lifetime licenses are available to those persons at any time during the year in which they will become age 65.

License valid from July 1 to June 30 of the following year.
